**7. Presentation on computerization of the functions of APPSC**

The Commission desires to computerize all the activities of the Commission and recruitments and departmental tests by obtaining detailed proposal from APOneLine.

**8.Any other Item with the permission of the Chair.**

- a) **Sri Shaik Shameem Saheb, Jr.Asst.**:-The Commission opined that the punishment imposed is far in excess of the irregularity committed. Hence, he shall be reinstated by reviving earlier order with stoppage of one increment with cumulative effect.
- b) **Departmental Tests**:- The Commission agreed in principle and said that it may be implemented with all necessary care.
- c) **Revision of syllabus**- The Commission noted in exercise done for revision of syllabus may be put up for consideration. After publishing in public department and thereafter scrutiny by an expert committee on the suggestions and objections received.
- d) **Sri.A.Pullaiah Naidu, Dist.Extension & Medical Officer**:- The Commission noted that Rules provide for the punishment proposed by Government and there cannot be any lesser penalty. It was also discussed whether it runs foul of right to livelihood guaranteed in constitution of India. As several decisions of higher courts have supported the penalty and is not struck down by any court, the Commission concurred with the proposal of Govt., (In fact Hon'ble Supreme Court upheld right of Govt., to invoke Rule 9 of APSC even in cases of grave misconduct, without pecuniary loss. In this case both embezzlement, though temporary is involved with grave misconduct, forgery).
